

## Scholarship and Tuition Discount for the 2023/2024 Academic Session

### 1. TUITION SCHOLARSHIP PROGRAMMES

#### 1.1 Undergraduate Programmes

- ❖ Pioneers Students: The first 100 students to be enrolled for the undergraduate programmes are entitled 10% tuition discount.
- ❖ The following discounts are obtainable based on the JAMB score: 10% discount on a score of 200-250, 15% discount on a score of 250-300, 20% discount on a score greater than 300. A 10, 15, and 20% discount are available on 5A1, 7A1, and all A1 in either WAEC/NECO.
- ❖ Two tuition scholarships are available for any qualified undergraduate from the host community of the university.

#### 1.2 Postgraduate Programmes

- ❖ First class graduates of AUST (undergraduate programmes) will be eligible for a 100% tuition scholarship for MSc at AUST.
- ❖ AUST graduates (undergraduate programmes) with degrees other than first class will be eligible for a 40% tuition discount.
- ❖ All other undergraduate students who are successful at the University entrance examination are eligible to tuition discount of 25%.
- ❖ All PhD applicants that meet the University entrance requirements are entitled to tuition discount of 25%

### 2. MULTIPLE SIBLING TUITION DISCOUNT POLICY

#### STATEMENT OF PURPOSE

If two or more siblings are enrolled simultaneously as full-time students at AUST as undergraduate or graduate students, a tuition discount will be granted to the students and/ or their family. The tuition discount rate for siblings enrolled full-time at the University is as follows:

- ❖ Ten percent (10%) tuition discount for the first sibling; fifteen percent (15%) tuition discount for the second sibling; and twenty percent (20%) tuition discount for the third sibling; and twenty-five (25%) tuition discount for the fourth sibling and additional siblings.
- ❖ The discount shall be applied in order of the year of enrollment of each sibling (i.e, first to enrol as an undergraduate student) and the discount shall continue to be applied as long as there is a continuous enrollment at the University.
- ❖ In the event of a discount involving more than two siblings with the same date of enrollment, the higher discount rate shall apply to the lesser tuition cost.
- ❖ Four or more students enrolled – 10% discount for the first two students; 20% discount for the third student; 25% discount for each of the fourth and any additional students

### 3. UPFRONT OR EARLY PAYMENT DISCOUNT SCHEME

Parents are allowed to present payment plan or pay in instalment every semester for their wards/children. However, the University offers a 5% early payment discount to students paying their annual tuition fee in full at the start of their course. To be eligible for the discount, 95% of the net tuition fee must have been paid to the University by the deadline dates as stipulated by the University.

### 4. ALUMNI DISCOUNT

Eligible University alumni commencing a programme will receive a 20% discount on their tuition fees. This discount applies to full-time and part-time postgraduate programmes only. You will qualify for our alumni discount if you have successfully completed one of the following at AUST:

- Undergraduate degree programme to include honors, non-honors, and integrated masters.
- Masters' programme including a postgraduate certificate/diploma and a PhD.
- Short certificate or diploma programmes.

### 5. ACCOMODATION SCHOLARSHIP

The University is offering 50% discount on accommodation for five (5) exceptional students that have excellent JAMB and WAEC/NECO results.
